Request for Trading Halt
Agricultural Land Trust (ASX: AGJ)

One Managed Investment Funds Limited (OMIFL) as responsible entity of the Agricultural Land Trust (ASX: AGJ) (AGJ or Fund) requests an immediate halt to the trading of the Fund's ordinary units quoted on the Australian Securities Exchange (ASX).

In accordance with Listing Rule 17.1:

- 1. The trading halt is necessary to assist the Fund in managing its continuous disclosure obligations as it expects to make a price sensitive announcement to the market in relation to the recently announced financial statements.
- 2. AGJ requests the trading halt remains in place until the earlier of the commencement of normal trading on Wednesday 4 March 2020 or when the announcement regarding the finalisation of investigations are released to the market.
